Survey of Public Rights of Way

NOTICE is hereby given that the Cornwall County Council, in exercise of the powers conferred upon them by Sub-section (3) of Section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Map and Statements prepared under Section 27 of the above-mentioned Act in relation to the Rights of Way within the area of the Municipal Borough of Penzance in the County of Cornwall by—

- (1) the deletion of the paths indicated in the First Schedule hereto;
- (2) the inclusion of the paths indicated in the Second Schedule hereto;
- (3) the amendment of the path indicated in the Third Schedule hereto.

Maps and Statements showing these modifications have been deposited at the offices of the Town Clerk, Municipal Buildings, Penzance, and at my office at the County Hall, Truro, where they may be inspected free of charge during the normal office hours.

Any objection or representation in respect of these determinations should be made in writing and addressed to the Clerk of the County Council at the County Hall, Truro, before the 31st day of August, 1956.

may make application to the High Court. Any such application must be made before the 7th September, 1956.

CHISLEHURST AND SIDCUP URBAN DISTRICT COUNCIL.
Maidstone Road, Ruxley to Chalk Wood, North Cray: Footpath Diversion Order, 1956.

NOTICE is hereby given that the above Order was made on the 23rd day of July, 1956, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the North Cray Ward of the Urban District of Chislehurst and Sidcup. The effect of the Order will be to extinguish two sections of the public right of way between Trunk Road (A.20), Ruxley and Chalk Wood, North Cray, described in Part A of the Schedule hereto at the expiration of twenty-eight days from the date of confirmation of the Order and to create certain new rights of way on foot in substitution therefor at the expiration of the said period of twenty-eight days as described in Part B of the said Schedule.
