SOUTHALL BOROUGH.

(Cherry Avenue to Ranelagh Road) Public Path Order, 1955.

NOTICE is hereby given that on the 30th day of January, 1956, the Minister of Housing and Local Government confirmed with modifications the above Order.

The effect of the Order is to create with effect from the 21st February, 1956, a public right of way on foot from the east side of Cherry Avenue at its northern extremity to the west side of Ranelagh Road at approximately 188 yards north of its junction with Beaconsfield Road.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Town Clerk's Offices, 7-9, South Road, Southall, and will be open for inspection free of charge between the hours of 9 a.m. and 5 p.m. Mondays to Fridays (inclusive) and 9 a.m. to 12 noon on Saturdays.

The Order becomes operative from the 11th day of February, 1956, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

WYCOMBE RURAL DISTRICT COUNCIL.

Wycombe Rural District Council, Flint Hall Farm, Hambleden, Footpath Diversion Order, 1955.

NOTICE is hereby given that on the 30th day of January, 1956, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order is to divert the public right of way running in a northerly direction from a point on the southern boundary of field No. 271, O.S. Bucks Sheet No. XLVI.10 (1921 Edition), and marked "A" on the map contained in the Order, for a distance of 1,020 feet or thereabouts, to a point near the eastern boundary of field No. 257 and marked "C" on the said map, to a line running in an easterly direction from the same point "A" and following the northern side of the existing boundary hedge for a distance of 200 feet or thereabouts, to a point marked "B" on the said map, and then

in a northerly direction for a distance of 970 feet or thereabouts, to the same point "C" where it joins the existing right of way. The existing right of way will be extinguished on the 5th day of March, 1956, and as from that date the path will be closed to the use of the public.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Council Offices, 17, High Street, High Wycombe, and will be open for inspection free of charge between the hours of 10 a.m. and 4 p.m. from Mondays to Fridays and between 9 a.m. and noon on Saturdays.

Survey of Public Rights of Way.

1. NOTICE is hereby given that the Cheshire County Council have prepared, in accordance with the provisions of Part IV of the National Parks and Access to the Countryside Act, 1949, draft maps and statements showing the public rights of way which in their opinion subsisted, or were reasonably alleged to subsist, on the 1st November, 1955, in the parts of the Administrative County of Chester comprised by the County Districts set out in paragraph 2 (b) below.

Any objection or representation with reference to the draft maps and statements may be sent in writing to the undersigned before the 16th June, 1956, and any such objection or representation should state the grounds on which it is made and the right of way which it concerns.
