Survey of Public Rights of Way.

NOTICE is hereby given that the Cornwall County Council, in exercise of the powers conferred upon them by Sub-section (3) of Section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Map and Statements prepared under Section 27 of the above-mentioned Act in relation to the Rights of Way within the areas of the Urban District of Bude-Stratton and the Urban District of St. Just in the County of Cornwall by:—

- (1) the deletion of the path indicated in the First Schedule hereto;
- (2) the inclusion of the path indicated in the Second Schedule hereto;
- (3) the amendment of the paths indicated in the Third Schedule hereto.

Maps and Statements showing these modifications have been deposited at the offices of the Clerk to the Council, The Castle, Bude, at the offices of the Clerk to the Council, St. Just, Penzance, and at the office of the County Planning Officer, County Hall, Truro, where they may be inspected free of charge during normal office hours.

Any objection or representation in respect of these determinations should be made in writing and addressed to the Clerk of the County Council at the County Hall, Truro, before the 9th day of March, 1957.
