Notice is hereby given that the Devon County Council, in exercise of the powers conferred on them by subsection (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Rights of Way Map and Statements prepared under section 27 of the above-mentioned Act in relation to the rights of way in the St. Thomas Rural District within the area of the said Council as follows:

Ashton ...	4	Delete whole of path from road south of Ashton Station to George Teign Road.
	8	Delete whole of bridleway from Rectory Lodge to Gate Park.
	9	Delete whole of bridleway from Lower Kiddens to Thornapark Cottages.
Aylesbeare ...	13	Delete whole of path from Podgers Pit to road west of Venn Ottery Common, via Aylesbeare Common.
	15	Delete whole of path from Parish Boundary west of Hill Gate Cottages to Parish Boundary north-west of Great Houndbeare Farm.
	16	Add footpath from Rindlehays to road near Minchin Court Farm.
	17	Add footpath from Rindlehays to road near Aylesbeare School.
Brampford Speke ...	8	Delete part of bridleway from Exeter City boundary through Lower Woodrow farmyard to its termination at road south of Higher Woodrow.
Bridford ...	26	Delete whole of path from road south-east of Laployd Barton to footpath No. 27 at Middle Hole, via Laployd and Beacon Down.
	35	Delete whole of bridleway from road west of Steps Bridge to Parish Boundary, along southern bank of River Teign.
Broadclyst ...	29	Delete whole of path from Exeter-Taunton Road by West Clyst Cottages to Pinhoe Parish Boundary, via Mosshayne Lane (joins Pinhoe footpath No. 15).
Christow ...	20	Amend classification from bridleway to footpath from road 130 yards north-east of Weir between Kennick and Tottiford Reservoirs to County Road south of Clampitt House.
Colaton Raleigh ...	5	Delete whole of path from footpath No. 6 on eastern bank of River Otter to Otterton Parish Boundary, south-west of Paver's Farm (joins Otterton footpath No. 22).
	19	Delete whole of path from road east of Popham's Farm to Pound Lane.
	28	Add footpath from Shepherd's Lane (formerly Vicarage Lane) along the Private Accommodation Road (not repairable by the inhabitants at large) running in an easterly direction to join Colaton Raleigh footpath No. 3.
Doddiscombsleigh ...	2	Delete part of path from road north-west of Easternhill to Parish Boundary by Kingscourt Cottage (joins Dunsford footpath No. 13).
	4	Delete whole of path from road near Town Barton, via Perry Lane to Parish Boundary at Webberton Wood (joins Dunchideock footpath No. 104).
Dunchideock ...	104	Delete part of path from road between Great Plantation and Webberton Wood to Parish Boundary at Perry Lane (joins Doddiscombsleigh footpath No. 4).
Dunsford ...	13	Delete whole of path from road south of Farrants Bridge to Kingscourt Cottages (joins Doddiscombsleigh footpath No. 2).
Harpford ...	7	Delete whole of path from Exeter-Lyme Regis Road at Goosemoor, southwards to Unclassified County Road.
	12	Delete part of path from a point approximately 200 yards south of Harpford Cottage, northwards and eastwards to the Ottery St. Mary-Sidmouth Road.
	13	
		Add footpath from a point approximately 200 yards south of Harpford Cottage running north-eastwards to the Ottery St. Mary-Sidmouth Road.
	30	Delete whole of path from footpath No. 11 to Sidmouth Urban District Boundary west of Bowd, via Harpford Wood (joins Sidmouth footpath No. 154).
32	Delete whole of path across Venn Ottery Common to Urban District Boundary at Westbrook (joins Ottery St. Mary footpath No. 43).	
Kenton ...	12	Add footpath from Exeter-Dawlish Road near B.M. 41.5 (Milestone Teignmouth 8), proceeding north-east across O.S. 367, 365 and 362 to Powderham Road by B.M. just south of junction of Rivers Kenn and Exe.
Lympstone ...	15	Delete whole of path, Strand to Path 16, via Harefield Buildings.
	28	Add footpath from Glebelands to Strawberry Hill.
Otterton ...	5	Delete whole of path from Stantyway Road to footpath No. 10 south of Crab Ledge.
	6	Delete whole of path from Stantyway Road to footpath No. 10 south of Chiselbury Bay.
	12	Delete whole of path from Chockenhole Lane to Holestone Lane along south-eastern bank of Otterton Brook.
	15	Delete part of path from Burnt House to Rydon Lane, via eastern bank of River Otter.
	17	Delete whole of path from road at Burnt House to end of road east of Pinn Barton.
	20	Delete whole of path from road at Otterton Park to join Path No. 10, via Home Down Barn.
	22	Delete whole of path from road south of Paver's Farm to Colaton Raleigh Boundary (joins Colaton Raleigh footpath No. 5).
	15	Delete whole of path from Mill Lane to Broadclyst Parish Boundary, via Mosshayne Lane.
Pinhoe ...	2	Delete part of path from road 130 yards north-west of Upexe Crossing to road east of Thorverton Bridge.
Rockbeare ...	2	Delete whole of path from Gribble Lane-Rockbeare Court.
	3	Delete whole of path from Strete Farm Road east of The Grange to Gribble Lane, via Tanners Farm.
	4	Delete whole of path, St. Andrews Church to Parish Boundary and small section west of Hill Gate Cottage (joins Aylesbeare footpath No. 15).
	5	Delete whole of path from crossroads at Westcott Farm to road south-west of the Vicarage, via Lions Farm.
	6	Delete whole of path from opposite northern end of Rag Lane to footpath No. 3 at Tanners Farm.
	8	Delete whole of path from road south-east of Rockbeare Court Farm to Higher Southwood, via Coppice Farm.
	9	Delete whole of path Higher Southwood Farm to road south of Lower Southwood Farm.
