Merton ... ..	2	Delete whole of bridleway from Potheridge Gate to Parish Boundary, via Specott Barton (joins Peters Marland bridleway No. 5).
	11	Delete whole of path from Merton Mill to Hillies Wood, via Curtice's Wood, Chelly Wood, Greatwood and Highridge.
	12	Delete part of path from footpath No. 11 near Merton Mill to Parish Boundary, via Clapper Copse. Add footpath from road north-east of Merton Post Office to Parish Boundary near Ivy Cottage (joins Huish footpath No. 3).
	13	Delete whole of path from Oxenham Court to Holly Cottage, via Rosehill.

#### *Beverley Rural District (Leconfield) Public Path Extinguishment Order, 1961*
