NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949

DEVON COUNTY COUNCIL

Sidmouth Urban District

Notice is hereby given that the Devon County Council, in exercise of the powers conferred on them by subsection (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Rights of Way Map and Statements prepared under section 27 of the above mentioned Act in relation to the rights of way in the Sidmouth Urban District within the area of the said Council as follows:

Path No.	Modification
18	Delete whole of path from Greenway Lane to Salters Cross, via Bulverton Plantation.
18a	Delete whole of path from Salters Cross to Footpath No. 18, via Bulverton Plantation.
44a	Delete whole of path from Core Hill Road to Footpath No. 45a, via Core Hill Cottage.
44	Delete whole of path from Exeter—Lyme Regis road east of Stowford to Core Hill Road.
45	Delete whole of path from road north-west of Fairpark House to Exeter—Lyme Regis road east of Stowford.
46	Delete whole of path from road south-east of Hollow Head Cottage to road south-west of Burscombe.
48	Delete whole of path from Ottery Lane opposite Green Head to road near Burscombe.
49	Delete whole of path from opposite Core View to Footpath No. 47 north-west of Brook Farm.
51	Delete whole of path from Sidford—Sidbury road north of Country House to Laundry Lane, by Sidford laundry.
54	Delete whole of path from Ottery Lane to Footpath No. 47 at Brook Farm.
54a	Delete whole of path from Ottery Lane to Green Head north-east of Black Pits Plantation.
55	Delete whole of path from Sidford—Sidbury road south of Furze Hill Farm to road north of Hillside.
55a	Delete whole of path from road north of Hillside to Footpath No. 54a north-west of Ebdon Farm.
57	Delete whole of path from Fore Street, Sidbury, to Footpath No. 58 north of Green Head.
58	Delete whole of path from Green Head west of Sidbury Church to road south-east of Goosemoor Farm.
62	Delete whole of path from road south-east of northern entrance to Manor House, Sidbury, to Bridleway No. 62a south of Road Farm.

Path No.	Modification
63	Delete whole of bridleway from road north of North Lincombe Plantation to East Hill Strips.
64	Amend classification from bridleway to footpath; from Bridleway No. 62a at Road Farm to Bridleway No. 65 at northern boundary of East Hill Strips.
93	Delete whole of path from Buckton Farm to road south-east of Buckley Farm.
95	Delete whole of path from Buckley Cross to road east of Hatway Cottage, via Buckley Plantation.
96	Delete whole of path from Buckley Road north of Cemetery to Footpath No. 95 at Buckley Farm.
144	Delete whole of path from opposite western end of Mire Lane to Exeter—Lyme Regis road east of Trow Farm.
145	Delete whole of path from Dunscombe Lane to Footpath No. 146. Add footpath from Dunscombe Lane, proceeding in a north-easterly direction over O.S. 483 to Slade Lane.
146	Delete whole of path from Slade Lane to Footpath No. 148 at Manor House, via Hermit's House Coppice.
147	Delete part of path from Footpath No. 137 east of Rempstone Rocks to junction with Footpath No. 148 at Dunscombe Bottom.
150	Delete part of path from junction of Footpath No. 147a and Footpath No. 148 to view point over Lower Dunscombe Cliff. Add footpath from Footpath No. 147a east of Lower Dunscombe Cliff to Footpath No. 137 at Rempstone Rocks.
154	Delete whole of path from opposite Bowd Inn to Urban District boundary on eastern edge of Harpford Wood.
157	Add footpath from Fortescue Road north of Higher Griggs Farm to Exeter—Lyme Regis road east of Sidford Bridge.
158	Add footpath from Riverside Cottage, Harcombe, southwards to Northground Lane.

These paths are shown on a Map which has been deposited at the respective offices of the Clerk of the County Council at The Castle, Exeter, and Clerk to the Urban District Council at the Council Offices, Sidmouth, and may be seen there free of charge during the usual office hours.

Any representation or objection with respect to this determination shall be made in writing addressed to the Clerk of the County Council, The Castle, Exeter, on or before the 11th day of May 1961, and shall state the grounds on which it is made.
