	25	<i>Add</i> bridleway from road south of Wagafor Bridge westwards over Hollow Moor and via Winsford Tower to Parish Boundary (continues in Black Torrington as bridleway No. 11).
	26	<i>Add</i> bridleway from road east of Northlew Manor via Four Shilling Moor to road south of East Stonequarry Farm.
	27	<i>Add</i> bridleway from road south of East Stonequarry Farm via Hollow Moor to Parish Boundary (continues in Black Torrington as bridleway No. 10).
North Tawton	12	<i>Delete</i> whole of path from Newland Corn Mill along western bank of mill leat to weir, via North Tawton viaduct.

	30	<i>Add</i> bridleway from the southern termination of bridleway No. 30 to the ford on the West Okement.
South Tawton	9	<i>Delete</i> whole of path from Stenteford Bridge to South Tawton Mill.
	28	<i>Delete</i> whole of path from Rising Sun to road south of Moor View, via West Week.
	29	<i>Delete</i> whole of path from West Week to road south of Dishcombe Head.
	45	<i>Delete</i> part of path from Mill Farm to north-western end of Throwleigh footpath No. 11.
	46	<i>Add</i> footpath from footpath No. 6 at Pixies Gardens, via Bottoms and Sandpit to join with bridlepath No. 21.
	47	<i>Add</i> road used as a public path from road north-east of Black Hall to Craydon Bridge, south west of Craydon.
	48	<i>Add</i> footpath from road used as a public path No. 47 eastwards through South Tawton Quarries and New Oxenham forking to join roads at New House and north of Stone Cross.
	49	<i>Add</i> footpath from Dishcombe northwards to road east of Shelly Ham.
	50	<i>Add</i> footpath from road north east of Shelly Ham, via Oxenham to Ring Hill.
	51	<i>Add</i> footpath from Ring Hill to road south of Trundlebeer.
	52	<i>Add</i> footpath along East Nymph Lane and Powlesland Lane to Parish Boundary (continues as footpath No. 1 in Spreyton Parish).
	53	<i>Add</i> footpath from Brandis Lane, via Broadpark Lane to road east of Livaton Cross.
	54	<i>Add</i> bridleway from junction with bridleway No. 24 by Ford Farm south west and east to junction with bridleway No. 24.
	55	<i>Add</i> bridleway from bridleway No. 22 to bridleway No. 23 west of Cawsand House.
	56	<i>Add</i> bridleway from road south of Ramsley Hill running southwards and dividing, one branch to join bridleway No. 36 the other branch proceeding south-westwards to the open moor.
	57	<i>Add</i> bridleway from bridleway No. 35 south to weir on Blackaton Brook, a branch proceeding westwards to rejoin bridleway No. 35.
	58	<i>Add</i> footpath from road east of East Week to Parish Boundary near Clannaborough Copse (continues as footpath No. 14 in Throwleigh Parish).
	59	<i>Add</i> footpath from bridleway No. 25 through Skaigh Wood along southern side of River Taw to re-join bridleway No. 25, between 800' and 900' contours.
	60	<i>Add</i> footpath from road south of Tawmoor Cross, via Wickington Lane to road north of Creedypark Cottage.
Sourton	8	<i>Delete</i> whole of path from road south of Lake to Southerley Down, via West Coombe Farm.
Spreyton	1	<i>Add</i> footpath from junction with path No. 2 south-west and west to Parish Boundary (continues as footpath No. 52 in South Tawton Parish).
Throwleigh	4	<i>Delete</i> whole of path from road south-west of Way to road south-west of Northdown.
	5	<i>Delete</i> whole of path from Wonson to road north of Wallandhill, via Northdown and Way Down.
	6	<i>Delete</i> whole of path from road north-east of Blackaton Bridge to footpath No. 5 south-east of Wonson.
	7	<i>Delete</i> whole of path from Deave Lane to Forder.
	9a	<i>Delete</i> whole of path from Clannaborough to Mill Farm.
	14	<i>Add</i> footpath from road north-west of Throwleigh northwards to Parish Boundary at Clannaborough Copse (continues as footpath No. 58 in South Tawton Parish).
