Amendment No. 2 (1963)

Notice is hereby given that on the 3rd day of October 1963, the Minister of Housing and Local Government amended the above Development Plan.

A certified copy of the amendment made by the Minister to the Development Plan has been deposited at the City Planning Department (5th floor) Commerce House, 13-17 Sir Thomas Street, Liverpool 2. The copy of the amendment to the Development Plan so deposited will be open for inspection free of charge by all persons interested between 8.30 a.m. and 4.45 p.m. on Mondays to Fridays inclusive.

The amendment became operative as from the 15th day of October 1963, but if any person aggrieved by it desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act, 1962, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment, he may, within six weeks from the 15th day of October 1963, make application to the High Court.

NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949

Barnstaple Rural District

Notice is hereby given that the Devon County Council, in exercise of the powers conferred on them by sub-section (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Rights of Way Map and Statement prepared under section 27 of the above-mentioned Act in relation to the rights of way in the Barnstaple Rural District within the area of the said Council as follows:

Berryarbor	1	Add footpath from main Ilfracombe to Combe Martin Road at Watermouth Caves across fields O.S. 791 and 795 to junction of path 13.
	25	Delete whole of path from road at Broadpark to B.3343 opposite Mattock Down Lane via Yellaton Lane.
Bishops Tawton	8	Delete whole of path from junction of footpath No. 4 at Hall's Whitemoor to road east of Venn Cross.
Bratton Fleming	16	Add footpath from road south-east of St. Peter's Church, westwards alongside churchyard to Almshouses and south along private accommodation road to road west of White Hart Inn.
Braunton	30	Delete whole of path from Braunton—Boode road to junction with footpath No. 31 at East Hill.
	62	Delete part of path from footpath No. 23 on southern side of Saunton Sands Hotel and along coastline to road east of Chesil Cliff.
Challacombe	3	Delete part of path from road west of Withecombe Gate to benchmark 1122 on southern side of Challacombe Common, via Whitefield Barton. Add path from road at Yelland Cross to benchmark 1122 on southern side of Challacombe Common via West Lane. Amend classification of whole route from footpath to bridleway; Yelland Cross to Parish Boundary south-east of Holwell Wood via West Lane, and Challacombe Common.
	9	Delete part of path running through Buscombe Farm and O.S. 36. Add bridleway running to the south of Buscombe Farm through O.S. Nos. 37 and 35.
	14	Add footpath from a point on the Lee Ball Cross to Wallover Down Gate road eastwards along southern boundary of O.S. 206 and northwards along western boundary to O.S. 215 to road south-west of Rectory.
Countisbury	14	Add footpath in front of Rockford Lodge.
Fremington	23	Delete whole of path from junction with bridleway No. 22 near Clampitt northwards to Taw foreshore.
	26	Delete whole of path from Penhill to Fremington Station.
	32	Delete part of path from west bank of Fremington Pill to Fremington Station beside railway.
	36	Delete whole of path from road by Fremington Post Office northwards to Taw Foreshore.
	63	Delete whole of path from road north-east of Chapple's Farm to Isley Marsh.
	64	Delete whole of path from Instow parish boundary at Paige's Pill to railway south of Isley Marsh via East Yelland Marsh.
Georgeham	5	Delete part of path from Putsborough to junction with Path No. 9 north of Higher Mill via Sharpland Lane.
Instow	9	Delete whole of path from Instow front road at Lane End along eastern side of Instow Sands and Cool Stone to Fremington Parish boundary near Paige's Pill.
Landkey	15	Delete whole of path from Landkey Newland to junction of path No. 13 by Mill Lead.
Moretehoe	8	Delete part of path from Barracane Beach northwards to Parade Road.
	8a	Delete northern path only leading from path No. 8 to Parade Road.
Pilton West	3	Delete whole of path from Barnstaple—Braunton Road to Foreshore of River Taw via western bank of stream.
Parracombe	2	Amend classification from footpath to bridleway; Challacombe Parish boundary to County Road A.39 south-east of Holwell Wood.
Swimbridge	12	Delete whole of path from road at Newtown to Trunk Road A.361 via Hurles.
	13	Delete whole of path from road at Yeoland Cottages to Swimbridge via Smalldon Copse.
Tawstock	9	Delete part of path crossing railway at Chapelton Station.
